Stud Females over 30 Months of age must have a calf at foot or be P.T.I.C. with a certificate from the veterinarian supplied to the Agents prior to the sale. Calves over 4months must hold adult registration. All Stud females are to be Pompes Free. Transfer of registrations will be at the Vendors Expense.

*All females to be yarded by 3pm Friday 26th April 2019. All Stud females will be inspected by 4pm to ensure they meet breed type and suitability. INSPECTORS DECISION IS FINAL.

*Entry Fee of \$50 + GST per female must accompany entry forms with Cheques made payable to "Ramsey & Bulmer". This fee will cover the advertising and cataloguing.

*No refunds will be given and no Substitutes will be allowed. Stud Females first in the sale followed by Commercial F1 Females.
