## Minutes of the previous meeting

 Minutes of the previous meeting were read and found to be a true and correct record Moved: Amy Harch Seconded: Cynthia Stark Carried
 Business arising from munities:

- Letter was sent from the South East Queensland Branch to the Gympie Sale committee with some questions and concerns regarding the sale.
  - Royce Sommerfeld (Gympie Female Sale Committee) explained the reasons why the committee requested vendors think about reducing numbers. He explained the drought was a contributing factor that affected the market at this time and the sale wanted to present a realistic number of lots.
  - Shane Bishop explained the reasoning behind keeping the nominations restricted to 5 for new vendors is important to ensure the nominations do not get too high (e.g. up to 300). He also explained that allocation issues should be assessed by the committee on a case to case basis to allow flexibility. Shane thought the committee was managing lot numbers well when the cattle numbers, clearance and averages are considered. It was advised that the rule model for the Gympie Female Sale was similar to that of Brahman week, in that vendors start with 5 lots and this increases each year.
  - Discussions were had around the marketing of the sale and the branch thought perhaps marketing and advertising could be increased to reflect that the sale is the premier ABBA female sale.
  - Shane Bishop advised that the rules model of the Gympie Female Sale are similar to the Rockhampton Brahman Week Sale in that vendors start with 5 lots and have the ability to earn more each year they sell.
- All agreed that the concerns raised in letter sent to the committee have been resolved and answered.

Motion proposed by Royce Sommerfeld that the allocation for new vendors remain at 5 Second: Caleb Wies Carried

- Bundaberg Feature Show
  - o Committee has been formed
  - Bevan Glascow informed the branch he will distribute the schedule soon, he is finalising the due date for entries.
  - Discussions were had regarding the mouthing of cattle. It was agreed that the
    person mouthing cattle should be completely independent from the Brahman Show
    and that decisions should be final.
  - Concerns were raised regarding the numbers of the cattle that will be nominated for the Bundaberg Feature show due to the timing.
  - The committee will monitor nomination numbers and make a decision whether it will go ahead this year.

#### - Merchandising

 Discussions around difficulties of deciding what merchandise the branch should purchase for events and concerns about the cost involved in doing this.

Motion moved by Bruce Godden that the branch talk to Anastasia Fanning and discuss the possibility of the branch being able to return items that are not sold at events to ABBA as per previous arrangement.

- If members are seeking more information regarding BJD they can contact their local DPI.

  Ivan Naggs from AgForce advised that this is a government issue that is constantly evolving.
